



Natural Gas Storage Mechanic (Wild Goose Storage)

Position Description

Reporting to the Superintendent US Operations, and as part of the Wild Goose Storage team, the successful candidate will ensure the safe, reliable, and efficient operation of the Gas Storage and field facilities. This role requires a self-motivated, hands-on individual with strong team skills.

Note: This non-exempt position is located in Gridley, California. All employees must reside within one hour of facility.

Primary Purpose of the Wild Goose Gas Storage Mechanic role:

Support daily operating and maintenance activities related to gas plant equipment to ensure safe, reliable, and environmentally conscious operations of the Gas Storage facility.

Key Accountabilities: Include the following:

- Responsible for the maintenance and repair of equipment associated with gas plant operations specifically engines, compressors, pumps, etc.; work to keep plant in good working order and acceptable appearance. Maintain facility to meet or exceed company standards. Help analyze and solve problem situations related to equipment.
- Be knowledgeable of plant regulations, more specifically air permit requirements. Stay aware of all environmental regulations, safety directives and operating procedures so that the facility can assure air compliance. Ensure that management is apprised of any area or issue that should be addressed regarding regulatory compliance including environmental, health and safety.
- Maintain a good relationship with all customers and respond to their inquiries and needs as required.
- Respond to plant related emergencies when called upon to do so.
- Help to coordinate third party contractor activities.
- Maintain equipment inventory for the plant, specifically engines, compressors, pumps, etc.
- other duties as may be assigned

Competencies:

All employees shall exhibit Wild Goose Storage's values of being a Reliable, Safe, Environmentally Responsible, Low-Cost Provider, of showing and accepting Accountability, and being Entrepreneurial.

Qualifications: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Education:

- High School Diploma or equivalent required.

Experience:

- 2+ years' experience in gas compression plant mechanics required
- Experience utilizing MS Office required.

Other skills, attributes, and abilities:

- In order to be successful in this position, one must possess a strong mechanical aptitude and excellent analytical skills.
- This position requires someone who can work well under pressure and has a strong commitment to safety.
- Individuals must have the knowledge and ability to analyze and solve operational problems to be successful in this type of role. Good communication skills are required.
- Position is part of a 24 hour, 365-day operation. Subject to being on-call most of the year. Normal and extraordinary work circumstances may often require without advance notice overtime after hours, on weekends, and holidays.

Physical Requirements in the role:

- The incumbent will spend the majority of their time in the field, thereby being exposed to adverse weather conditions, (heat, cold, wind), and hazardous environments. Must have good physical stamina to work long hours in the field.
- Must be able to comfortably climb ladders and stairs and work at heights.
- Must be able to lift a minimum of 50 lbs.
- Must be able to work in confined spaces for up to one hour at a time.
- Must have the ability to walk on uneven ground for up to 2 miles during Pipeline activities.
- Must be able to work with hands below knees and or above shoulders for short periods of time up to 10 minutes.

- Successful completion of a pre-employment medical examination by a doctor selected by our company,
- Pre-employment Drug and Alcohol testing required,
- Satisfactory references regarding your work history and qualifications,
- Background check required,
- It is anticipated that you will be required to regularly operate a company vehicle for or on behalf of our business and you are required to hold and provide a copy of a valid driver's license and provide a copy of your driver's license abstract information.
- Please note: this position falls under regulation by the U.S. Department of Transportation, and as such will be subject to random drug testing according to DOT requirements.
